- ✓ Start a filing system for your financial records, such as tax returns and statements for your retirement accounts, investments and bank accounts. - ✓ Make lists of where to find your accounts, insurance policies, birth certificate, passport, and financial and legal advisers.

- ✓ Check the beneficiaries for your retirement accounts and insurance policies. Think about all of your accounts that require you to designate a beneficiary. If there's been a change, such as a marriage, divorce, birth of a child or a death of a loved one, you may need to update your beneficiary information on some or all of your accounts to reflect your current wishes.

- ✓ Execute a will, health care proxy and durable power of attorney documents. Develop or update your estate plan to ensure that the people who depend on you are protected and your final wishes are honored.

Protecting your personal information can reduce your risk of identity theft. Here are precautions you can take to help keep your online account safe.

- Change your passwords regularly. Use a unique password that's a strong mix of upper and lower case letters, numbers and special characters. Avoid writing down or emailing passwords or Personal Identification Numbers. Don't share passwords or PINs or answers to security questions with anyone.
- Monitor your account frequently. It's easy to log into your OkMRF account any time.
- Take care of your computer and mobile devices. Install the latest operating system, patches, and antivirus and antispyware software.
- Don't use an automatic login feature that saves your user name and password, and always log off when you're finished viewing your account.
- When you access your account in an airport, library, hotel or other public place, be sure you're using a secure wireless network so your information is protected.
